I travelled to the nation's **Generation Change:** capital twice in the month of September for two high-level strategic meetings. In the first meeting, I attended a leadership conference and an Iftar dinner hosted by the U.S. Secretary of State Hillary Clinton. ## SomaliCAN iyo Aqalka Cad Ka bog 1

After several guest speakers charged with setting the mood -- Naif Al Mutawa, the creator of The 99 comic books; Herro Mustafa, subject a film called American Herro; the co-producers of New Muslim Cool, Hana Siddigi and Kauthar Umar; and comedian Ahmed Ahmed -- the group broke into three separate "think tanks" to discuss issues of religion. culture. identity, global and affairs. breakout sessions were held so that participants can listen to a speaker of choice their or contribute to discussion on a subject matter of interest to them. Each group reported the results of their discussions to the whole group.

Farah Pandith, the U.S. Special Representative for Muslim Communities was the master of ceremony at the event. Farah stated that the doors of her office are open to all members of Generation Change. She requested each leader to share ideas and insights with the department through channels that were provided to all founding members of Generation Change.

After the call to prayer and the breaking of the fast, Secretary spoke to these young leaders and other Iftar guests about America's commitment to values going back to the very beginning of our nation. recalling a quote from George Washington. Looking around the room, she said the "real story of Islam in American can be found in this room and rooms across America."

#### The White House

A follow up conversation was held at the White House on Septemer 14 for 60 African leaders from around the country. The meeting, dubbed Youth and Visions for the Future of Africa - A Follow-Up President's the Young to African Leaders Forum, was a strategic planning session to identify the most pressing needs of Africa, opportunities for trade and exchange, and ways that the African communities in America can contribute to the development of Africa.

In a panel discussion format, administration officials delivered the administration's position on policy issues of concern to Africa. Panelists included U.S. Assistant Secretary of State for African Affairs Johnnie Carson, U.S. Assistant Secretary of State for International Organization Affairs Esther Brimmer, U.S. Assistant Secretary of State for Public Affairs Judith McHale, and White House Senior Advisor Michelle Gavin.

## Register to Vote:

## Voter Registration Ends the first Monday of October, Oct. 4, 2010.

Columbus, OH - The deadline to register to vote in the November 2, 2010 General Election is October 4, 2010, so any registration form must be returned either in person or postmarked no later than October 4, 2010.

## You must Register or Re-register to Vote if:

- \* You have become a United States citizen after last election.
- \* You just turned 18 years old or you will be 18 year old on Election Day
- \* You have changed your address after the last election.

Supplemental Security Income Notices to Certain Refugees and **Humanitarian Immigrants**

Supplemental Security Income Notices to Certain Refugees and Humanitarian **Immigrants** 

Beginning in September 2010, certain refugees and other humanitarian immigrants who are receiving Supplemental Security Income (SSI) began to receive notices indicating that their benefits will stop. The Social Security Administration is taking this action because, for some, the two-year extension in eligibility provided by the SSI Extension for Elderly and Disabled Refugees Act (P.L. 110-328) will expire on October 1, 2010. Others will continue to receive benefits until their 9 years of eligibility expires or until September 30, 2011, whichever comes first.

The notices contain specific language regarding how these individuals may be able to continue to receive SSI. In general, individuals who receive the notices may still be eligible for SSI if:

- They have applied for U.S. citizenship with the Department of Homeland Security and their application is pending, or
- Their application for U.S. citizenship has been approved.

If either situation exists, the individual should submit proof to their local Social Security office. For those individuals who provide proof that their citizenship applications are pending, SSI benefits can continue through September 30, 2011, when the SSI extension law expires. Please note: Once these individuals become U.S. citizens, SSI benefits are no longer time-limited.

Class Action: The Kaplan Class on U.S. Citizenship Applications

This class action, called the "Kaplan Class" settlement allows individuals to ask the Department of Homeland Security to expedite a pending application for U.S. citizenship and to ask for a waiver of any associated fees. ## Anonymous Donor's Pocket Change Really Adds Up

The Salvation Army in Cincinnati announced it received a contribution of almost \$1100 – all in coins! The donor, who wishes to remain anonymous, had been collecting his 'pocket change' in an over-sized, plastic Coca-Cola bottle. It took a few days to process all the coins, which included everything from pennies to Susan B. Anthony dollar coins. The final tally came to \$1092.06 and will be used for social services programs in the local community.

"Over the years, I would always just throw my pocket change and miscellaneous coins in this big old Coke bottle, and it eventually filled up," stated the donor. "I found out that there wasn't any easy way to count all those coins, or run it through a machine, so I had the idea to donate it to **The Salvation Army**, anticipating they have coin counters for the donations they receive in the kettles every Christmas." "The Salvation Army is delighted with every contribution that helps us fulfill our mission," stated Matt Pearce, Divisional Development Director for The Salvation Army. "This certainly is a unique contribution, but it added up to be very substantial, and we're very grateful that the donor thought of The Salvation Army."
